

Extremely rare Israeli strategic map of the Arabian Peninsula showing oilfields and associated infrastructure. Printed in black, red and blue, the map demarks the political boundaries of the time along with the areas covered by oil companies' concessions. Pipelines form a web across the northern part of the Arabian Peninsula (shown in an uncommon vertical orientation), while oilfields and refineries, large and small, are also marked. The IDF probably made the map in responce to the 1956 Suez Crisis and its associated geopolitical shifts. With the Egyptians operating the Suez Canal, and the USA forcing Britain and France to abandon their post-imperial plans, Israel now counted in both U.S. and Soviet plans for their control of Middle Eastern politics. Britain had to anchor its Middle Eastern influence in Cyprus, Aden and Iraq, while the increased American influence can be seen in the huge swathe of territory assigned to Aramco. We have located only one institutional copy of this map, in the National library of Israel.



First edition of a work on the relation between the Republic of Venice and the Persian Empire (present-day Iran), focusing on their diplomatic and commercial relations, written by the Italian historian and politician Guglielmo Berchet (1833–1913). It contains valuable information on how goods from Asia, like spices and silk, were transported to Venice via Persia. Included at the end are transcriptions of related material, mostly state documents and letters, dating from 1463 to 1718.

## Ledger recording involvement in numerous infrastructural projects in Africa, Asia and the Middle East (1952–1955)

Manuscript ledger recording the work hours of F.A. Boulten, from 1952 to 1955. Although Boulten's specific field of work, or even the company he worked for, is not stated, he worked on engineering and infrastructure projects in the British colonies, the Commonwealth and other states in Britain's sphere of influence (most notably Iraq). Each day he devoted 1 to 3.5 hours to multiple power plants, oil terminals, bridges, dams and harbours. As Boulten worked on most of the projects before construction had started, it is probable that his firm was related to the initial financing of the project. A probable suspect for the latter is the Colonial Development Corporation, founded by Great-Britain after World War 11 for the economic development of its colonial territories. The CDC provided loans for many of the projects mentioned in the ledger. These projects include: the power stations of Aden, Melbourne and Singapore, the oil jetties at Al-Faw near Basra, the harbours of Sierra Leone, Lagos and Mombasa and in Iraq the Adhamiyah Bridge, Darbandikha Dam, Taq Taq Bridge, Lake Tharthar and the Mujarah Canal.

Boulten worked 7.5 hours, five days in a week and mentions the days the office was closed, Bank Holidays, sick leave and days off, including one to have an x-ray taken. One of his off days was 2 June 1953, Coronation Day, and he drew a crown above the name of the month. On 15 February 1952 he marked the funeral of King George VI, but spent the day at the office.



Extremely rare and classified at the time of release: one of the first maps to depict clearly the Abadan Petroleum Refinery, the first oil refinery in the Middle East. The map of the Khorramshahr-Abadan area of Iran and the lower Shatt al-Arab waterway at the head of the Arabian Gulf was published in the early days of World War I, when protecting the refinery was Britain's primary objective in the region. Published in Calcutta by the Survey of India, predicated on the best and most recent surveys. Labelled "For official use only".


First and only English edition of a treatise on England's national debt and how to solve that problem, translated from the French (*Considérations sur quelques parties du méchanisme des sociétés*. London, T. Spilsbury, 1785) by Parkyns MacMahon.

Charles de Casaux (1727–1796), a French economist, sociologist, agronomist and proprietor on the island of Grenada, became an English subject by the cession of the colony in 1763 and devoted much of his time to the cultivation of sugar cane – he also wrote on the subject.

He refers frequently to the statistics and analyses of Arthur Young and Sir Charles Whitworth, and also mentions Adam Smith (p. 135). The author, an intimate of Diderot, editor writes in the preface (p. xIV): "I shall again suppose, as another result, that it has been a mistaken notion, to imagine that the revenue of the people must be lessened, in order to increase that of the prince: — What is that to the prince — what is it to the people — provided both be now convinced, that it is not possible to enrich the one, either really or nominally, without enriching the other in the same manner, and in the same proportion?"



First edition of an investigation of the effects and consequences of the Panama canal on the Dutch overseas trade, compiled by a committee appointed by the Dutch minister of Water Affairs. It consists of a introduction, a list of appendixes, seven appendixes (lettered A-G), all loosely inserted in the portfolio, containing a list of publications on the Panama canal, a list of ports in America, Asia and Australia whose travel time are affected by the canal, the influence of the canal on the South American trade, and more.

## On the shells that were used by indigenous peoples as means of payment in ancient Africa and Asia

Original edition of this study on the Cypraeidae from the Dautzenberg collection of shells by Franz Alfred Schilder (1896–1970), a professor of zoology at the University of Halle-sur-Saale where he taught zoogeography and statistics. Cypraeidae are the shells that were used by indigenous peoples in ancient Africa and parts of Asia as means of payment (currency). Since the time when Schilder read an ethnological work *Muschelgeldstudien* by O. Schneider, he became interested in studying the *Cypraeacea* and wrote his dissertation about it. *Cypraeidae* was Schilder's main research interest throughout his life. Along with his wife, Maria Schilder they were a prolific team of mollusk systematists.

On pp. 236–239 there is a bibliography of Dautzenberg's papers on living Cypraeidae. In very good condition.

Signed copy of the original contract of 1 May 1753 by Willem Gideon Deutz (1697–1757), an Amsterdam banker and former plantation owner and at that moment mayor of the city (which he was up to five times), on his famous negotiation fund for Surinam plantation owners. In this copy, Deutz outlined the conditions that both parties of the fund, namely the investors and the plantation owners, had to satisfy. It contains information on the interest rates of the loans, but Deutz also speaks upon the terms of repayment and the amounts of money the colonial plantation holders had to refund.

With the seal and signature of Willem Gideon Deutz at the end of the act and a manuscript list of the amounts of interest that the subscriber ("No. 3382") received from the obligation fund and a stamp with "Afgegeven 20 coupons van An[no] 1818 à 1837". With a small fold in the *Verkort plan*. With some tears on the folding lines, some are repaired with (older) tape. Otherwise an important act for the history of Dutch involvement concerning Surinam plantations and the Dutch colonial impact in Suriname.

## Portugal's political and economic decline, with extensive chapters on France and the Umayyad Caliphate



Rare first and only edition, in Portuguese, of a monograph on Portugal's political and economical decline, in two volumes, by Antonio Maximino Dulac (1768–1850). The author examines the historical, political, agricultural and economic background of Portugal, comparing it to other countries in Europe and elsewhere, and trying to find "remedies" to "cure" the Portuguese state. The first volume includes an extensive disscussion of France, and the second of ancient Egypt and the Arabs in the Iberian Peninsula. He gives special attention to the Umayyad dynasty, especially the reigns of Abdullah (855–912) and Abd-ar-Rahman III (889–961).

The original Dutch edition (*Nederlandsch India, in haaren tegenwoordigen toestand beschouwd*) appeared most likely in the same year. Landwehr & Van der Krogt suggest that the two were published simultaneously and may have been printed in Amsterdam.




Collection of 3 unrecorded Dutch print series of the Levant trade. The first by Pieter Stevens van Gunst (1659–1724) with 8 prints showing ships at the Levant being unloaded, lying at anchor and getting attacked by pirates. The second series with 6 prints by Johannes de Ram (ca. 1647–1696) showing the Dutch convoy protecting trade ships, probably on their way to the Orient. The third (anonymous) series shows inhabitants of the Orient in some scenes trading with Dutch merchants and with Dutch ships in the background. Although the 3 series are engraved in quite different styles, they have a similar subject and look surprisingly good together.

#### The first British trade agreement with Mocha


First Dutch edition. Edward Heynes' account of the first successful attempt of the British (the third altogether) at establishing trading privileges with Mocha and a commercial presence there, previously published in English within the first volume of Samuel Purchas' collection "Hakluytus Posthumus, or Purchas his Pilgrimes" (1625).

The ship "Anne Royall", captained by Andrew Shilling, sailed in April 1618 up the Red Sea and visited Mocha from April 11 till August 20. Heynes, secretary to Sir Thomas Roe, gives an extensive account of the reception by the governor of Mocha, customs of the population, and prospects of commerce. "[The] British delegation lands, and presents the governor with six yards of broadcloth stammell, six yards of green material, a shotgun and mirror. It is striking that the British respond to their hosts' food gifts with gifts of technology. This form of reciprocity sends a message of power, for not only does it reflect the greater sophistication of their economy, it also implies that the Yemenites are no match militarily" (Malkiel, p. 10). Includes a short account of a trip made by Heynes' fellow-merchant Joseph Salbank to Sinan.



Second edition of an interesting work on energy-saving heating systems by Johann Christian Lehmann from Leipzig, professor of medicine and physics. The high wood prices and the large quantities necessary for heating prompted Lehmann to improve the construction of stoves in order to save energy. He calculated that his proposal would reduce the fuel costs with two thirds. The first edition was published in 1735 as *Utilitatis physicae verae specimen VI : ars lucrandi lignum d.i. Universal-Holtz-Spahr-Kunst*.



Second edition of a beautiful wholly engraved book on practical mathematics, fortification, mensuration, weights and monetary values of the Netherlands, France, Italy and Spain. The first work, with hundreds of engraved geometric figures and diagrams; fortification plans, elevations, cross-sections and perspective views, and tables, covers geometry, arithmetic, trigonometry, mensuration and fortification. The second work expands the first's brief account of arithmetic and adds sections on weights, measures and monetary units for France, Italy, the Low Countries, England, Germany and Spain.

The plates appear to have been originally produced and sold separately, as most plates have their own address, and one is dated 1664. Luders appears to have first published the *Arithmetique* in 1663 and the *Mathematique* in 1664. Another undated edition appeared ca. 1684.



Ad 1: reissue of the enlarged and corrected 1707 edition of a collection of texts regarding maritime law. It contains the Medieval laws of Wisby, the laws of the Holy Roman Emperor Charles v of 1551, the laws of Philip II of Spain of 1563 (including articles on the equipage of ships, the rights of sailors and merchants, and insurance), the laws of the Hanse, and the regulations of the city of Amsterdam (including regulations for voyages to Rotterdam, Utrecht, Antwerp, Rouen, London and Hamburg). It was first published in 1532, followed by numerous editions well into the 18th century. It is followed by a merchant's guide on the insurance of ships and merchandise at sea by Quintyn Weytsen, here enlarged and corrected by the Dutch legal scholar Simon van Leeuwen. The third part contains the insurance regulations of various Dutch merchant cities, the fourth part is a list of import taxes of various goods, and the fifth part gives the regulations for ships' pilots.

Ad 2: Fourth edition of Van Glins's commentary on the maritime laws of Philip II of Spain of 1563. It was first published in 1665 and "remained the standard work on the Dutch maritime law for a long time" ("Bleef langen tijd het standaardwerk over het Nederlandsche zeerecht", NNBW). It gives extensive commentary on all the articles from the laws of Philip II of Spain, concerning the equipage of ships, the rights of sailors and merchants, and insurance, as issued in ad I.



Second edition of an interesting investigation of the policy, conduct and operations of the Hudson's Bay Company on the Pacific coast and in the Canadian north-west, by the historian and statistician Robert Montgomery Martin (1803(?)–1868). The Company was founded in 1670 and originally traded in fur, but also functioned as a de facto government in North America. In the 19th century the company grew and traded all sorts of wares. The first chapter deals with the geography and climate of the area, the second with the "constitution and working of the Hudson's Bay Company", the third with "the Indian population, their numbers, character and treatment by the Hudson's Bay Company", and the fourth with the "christian conduct and beneficent policy of the Hudson's Bay Company", closing with a summary.

## 381-page prospectus for a "world-class" commercial dictionary in 5 folio volumes, never published

Fine copy of an interesting and very extensive prospectus, by André Morellet (1727–1819), announcing a new commercial dictionary in 5 folio volumes and calling for subscriptions. He first explains why a new dictionary is needed, extensively describing the first commercial dictionary in Europe of Jacques Savary des Brûlons. He also mentions English dictionaries of commerce. He found all these dictionaries far from complete, omitting many interesting details and says they are not as universal as they claim. So in the present prospectus Morellet proposes a new, complete, universal commercial dictionary, and describes the differences between his planned dictionary and the existing ones. The prospectus is very detailed and well organised, no doubt because he needed to convince his public of the need for such an extensive and therefore probably expensive dictionary. Morellet worked on his dictionary for 20 years before the French Revolution interrupted him, but never published the dictionary itself.

With a couple rust spots in the paper and occasional very minor foxing, but otherwise in fine condition. The binding shows a few scrapes and scratches on the boards and is slightly worn at the hinges, but still very good. A remarkably detailed record of a project that unfortunately never came to fruition.



### Very rare publication of new Russian import regulations

Second known copy of a commercial publication of statutes, promulgated in French by the Russian Empress Catharine the Great, concerning import duties for commercial merchandise in Russian ports and at other frontiers of the Russian Empire as they were determined and accepted in 1782. There is an exception for Astrakhan, a major port and market city in southern Russia at the head of the Volga river, which was under the government of Siberia, which apparently maintained its own commercial regulations.

This publication is very rare, WorldCat lists only I copy (Kress Library of Business and Economics, Harvard University). Other libraries worldwide have only the microfilm of the Kress copy.



First edition of an early attempt to establish a moderate and lawful interest rate for money lending, by the French Protestant Claude De Saumaise, successor to Joseph Scaliger at Leiden University. With a 93-page index of classical sources listing authors and subjects in Greek and Latin, and a discourse on ancient coinage. Based on one of De Saumaise's earlier works, the shorter tract *De Usuris*, first published one year earlier.

A very good copy with generous margins and only an occasional minor marginal worm hole. An influential Elzevier publication on usury, interest rates and ancient coinage.

### First great international investment fraud & scandal

Third edition of a famous collection of texts and plates satirizing the Englishman John Law, his Mississippi Company, and the international land and trading speculation in worthless shares of the South Sea Bubble of 1719–1720, which resulted in an international scandal. The speculation began in Paris, London and Hamburg, spreading to the Netherlands in the summer of 1720. While plays satirizing the speculation already opened in September 1720, the bubble really burst in October. Within each edition the number and makeup of the plates varies greatly from copy to copy. Muller gives a list of 74 plates in the most extensive contemporary published list, but no copy of any edition includes them all (some are alternatives) and several plates frequently included are not in those lists.

Without the often lacking 5 leaves of text containing the *Copye van een brief*. Some tears restored in the margins, several leaves strengthened along the folds, stains in the first plate and title-page and some occasional thumbing. A fair to good copy. Binding rubbed along the extremities, notably affecting the spine, but still firm and with a modern title-label.



First edition of the renewed treaty, originally concluded on 11 April 1713 in the framework of the Peace of Utrecht, simultaneously published in Paris, L'Imprimerie Royale, 1740, while the French text was also printed in the same year by the same printer Scheltus (Knuttel, 17128). The important treaty is on free trade between the two countries and on common tariffs and imposts ('d'établir un tarif commun'). After 25 years therefore, a revision had become necessary. The negotiators were Jean-Jacques Amelot de Chaillon (1689–1749) and the Dutch Embassador in Paris Abraham van Hoey (1684–1766).

Contemporary collection of 4 extremely rare printed ordinances and regulations concerning fishery and the fish trade at Veere, near Middelburg in Zeeland, none recorded in NCC or STCN, plus 7 manuscript extracts from minutes of the meetings of the Veere city council on the same subject. The city had been a leading fish market place since the Middle Ages, held a privilege for the inspection and taxation of fish caught in the region and authorized the auctioneers. To avoid taxes some people transported fish out of the city before it was sold. The first three ordinances attempted to reassert control over the fish trade, though the fact that the authorities found it necessary to issue new ordinances every few years suggests they were not very successful. Each ordinance refers to the previous one, showing that the Council issued none between these three. The fourth printed item gives guild regulations for fishermen using the city harbour, who are required to register their crew members, keep them orderly and make payments to the guild. The manuscript begins on the final integral blank of the 1771 ordinance. From differences in the handwriting it appears that these extracts of minutes were written over the years as the issues came up in the Council. Amusingly, the family name of the printer and publisher of the 1774 regulations is "De Vin" (The Fin).

In very good condition. Spine faded and tattered. A remarkable contemporary collection of unique items concerning fishery and the fish trade in Veere.
